DISTRICT COMMISSIONERS REPORT

Craig Kidd | District Commissioner

Scouting actively engages and supports young people in their personal development, empowering them to make a positive contribution to society. In partnership with adults, young people take part in fun indoor and outdoor activities. They learn by doing, by sharing in spiritual reflection and by taking responsibility. They make choices, undertake new and challenging activities, and they live their Scout Promise.

Northampton District continues to be in a strong position offering amazing opportunities to young people and adult volunteers through the town. The end of the financial provides year opportunity to look our performance over the past 12 and start to ensure concrete plans are in place for the next year.

Growing Our District

Last year (2017-2018) we were celebrating a bumper year of growth within our District, and as a result was always going to be difficult to follow. The High's of the previous year could not be matched and as a result we experienced a fall in our overall youth numbers. In real times this means that less Young People are enjoy Scouting within our communities.

Surprisingly, the biggest fall in our numbers was within the youngest sections with 54% of our Groups experiencing falling numbers within Beavers

Whilst these numbers are disappointing, there are positives to be taken, namely the growth within the Scouts section which rose by 9%. This is particularly pleasing as the age 10.5 to 14 years has traditionally been a difficult age to retain in, with increased competition from other activities, personal interest and of

course education, its refreshing to see such great growth within this section, this is likely down to the high quality programme on offer within our groups.

Therefore the 2019/20 focus has to be on growth and much work continues to go into growing the membership through supporting growth. We are lucky to have many groups delivering Scouting in the town meaning that no young persons is more than a couple of miles from their local Scout Group, however in some cases that doesn't mean they know how to access it and through our growth strategy we need to ensure that we can make it easy, and make Scouting feel inclusive relevant for everyone who may want to get involved.

Our key priorities have to be:

- Ensuring our Scouting provision is reflective of the community of Northampton.
- Ensuring we continue to develop and deliver high quality programme bring Young People to our Groups and Units
- Recruit the volunteers to help us deliver Scouting within our Groups.
- Support each other to ensure that the full potential or our Groups and Units is realized

Supporting Our District

Much of this year has been about trying to provide a support structure that helps our volunteers deliver and our groups flourish.

One of our key objectives was to put a structure in place for our assets and migrate them to Active Support Units. The aim is to provide а governance and management structure that supports the activities delivered by these SASUs in a sustainable way. ensuring that they deliver what is required of them to support the aims of Scouting in Northampton. I still firmly believe that this is the right way to go, and having clearly agreed objectives for our SASUs is key to keep things moving forward, however I think there are many lessons we need to learn as the implementation hasn't always been an easy one and we have much work to do to achieve these objectives going forward.

We have always been good at providing key events within the District, our camps and competitions are regularly well attended but our support must extend beyond this, I am pleased that this year the team has been able to get out to visit more groups and sections and this must continue as we move forward.

I am also pleased that after a significant amount of work we were able to launch our new look website which provides us a platform to deliver a greater deal of support and information to everyone, we are slowly building up the materials on there and I would encourage everyone to spend some time familiarising themselves with the content available.

Also this year we delivered our first ever leaders support weekend, the aims of which were to deliver key scouting skills training to our volunteers. This event a significant investment from the District both in terms of money and time was on large a success, however attendance wasn't as great as we'd hoped but for those that came along the feedback received was hugely encouraging.

Our People

To deliver Scouting in our town we rely on a large number of people, working together and heading in the same direction. When we achieve this the results are unquestionable and for much of this year we've had that in place, we successfully filled the majority of our key roles and as a result we're been able to delver key support to our groups.

We have however suffered from inconstancy and attrition within the District Team, having seen some of our key team members move to focus on other challenges, resulting in slow progress. This has been particularly the case within our Beaver Section and Scout Section, both Chris's (our ADCs in Beavers and Scouts) took on the challenge to move their respective sections forward and

they both made significant progress, leaving the sections in good shape and I thank them for their efforts and commitment.

I am pleased that we have been able to fill the ADC Beavers role with Karen Simpson taking on the challenge her enthusiasm and experience will serve our Beaver section well.

We have however been unable to fill our ADC Scouts role and its key we find a way of continuing to provide support to this section.

After our 2018 show Debbie Bromley also stepped down from her role as SASU Manager for the Gang Show, Debbie oversaw some significant developments in the show, including ensuring financial sustainability as well as the relocation back to The Derngate. I am hugely grateful to Debbie, and of course her team for safeguarding the show.

This year Malcolm stood in to support the show and was ably assisted by Angela Woods who assumed the role as Chair, it was an important year for our show and I am hugely appreciative to Malcolm, Angela and the whole Gang Show team for delivering a remarkable 60th anniversary show.

We also established an awards committee Chaired by Alan March and will begin to see wider recognition to our volunteers for their exceptional commitment to Scouting within Northampton.

As we exit this fiscal year and head into our AGM Alistair Cochran has made the decision to step down from his role as District Chair. Alistair has held the role since 2012 and has been a huge asset to our District. I would like to thank him for his support over this time.

This year also saw our District Youth commissioner, Jack Brooker turn 25 and move on from his role, I am hugely excited that Charlie Mackenzie agreed to take it on, Charlie has a real passion for Scouting and he is making a huge impact in our Youth Shaped Scouting strategy. You can read what Charlie is up to in his monthly Blog on our website.

The District Team are a huge asset to our District and I'd like to thank them all for every moment they spend supporting what we are doing, as DDCs Malcolm and Elaine have done a remarkable job driving key initiatives forward, and Esther has consistently provides a first class programme to the Cub section. I would like to convey my thanks to them and everybody else on the team and the Exec for making such a difference.

Our Programme

Programme is at the heart of all we do, quality programme has kept Scouting strong over the past 109 years and needs to continue to be at the heart of Scouting in Northampton.

As a District our support has focused on providing experiences

that compliment what is being delivered week in week out by our fantastic section leaders, the true value in events like this is that our young people get to experience Scouting outside of their own groups, and start to realise that in some small way they are part of this family of 38 million Scouts worldwide.

In addition to the experiences we have invested significantly our activities infrastructure to help support our groups deliver an exciting programme, this included development of the archery range at Overstone, the introduction of a Cavebus, new and improved activities in Roy's Challenge as well as agreement to invest in both a hammock hotel and a frisbee golf course. We have also made huge progress in converting the old Lodge and Radio Shack into a new District Resource Centre something I am confident will deliver something unique to support our volunteers.

Our Future

Our focus over the coming period will be to continue to develop the Scouting offering within the town.

I am hugely excited about two projects that we are actively working on with the SEN and the Muslim community of the town. Both these projects should see us open up Scouting to a wider and more diverse range of young people and volunteers.

We will also grow our relationship with the University and their

Changemaker programme as we seek to find ways to engage students within our activities and groups.

We must also continue to develop and invest in our key assets, this becomes more complex as the projects start to require more significant capital expenditure, but I am pleased that the Trustees have backed a plan to create a fundraising committee who will work actively with our assets and their agreed development plans to help them explore sources of funding to realise their potential.

Focus this year must also spent on our volunteers, we need to provide the right skills and tools necessary to deliver, I'd like to ensure we support new volunteers through the start of their journeys in a consistent and valuable way. We must mirror the effort being put in at the County towards training to ensure our volunteers progress through the training scheme efficiently so our volunteers can continue to delver high quality Scouting.

All together this is a really exciting period to be involved in Scouting within Northampton and I hope you share my enthusiasm that Scouting in the town is going from strength to strength. Thanks to everyone involved and keep up the amazing work, enjoy the year ahead.

This has enabled an incredible 13 Young Leaders to achieve their Young Leader Belt during the year, with some progressing to adult leadership.

My continued belief in integrating Senior Awards into the Explorer Programme has enabled us to deliver 10 Platinum and 3 Diamond Chef Scout Awards this year along with 5 Bronze, 9 Silver and 1 Gold DofE Awards.

We have again had a good year of bookings at the centre with numbers from the County steady following last years rise with our other bookings also maintaining their numbers. We continue to have some midweek bookings but this is the area that we believe can be further developed and as said before we feel that working in liaison with our other assets we can increase this usage which would see a significant rise in revenue.

With our Chief Scout Bear Grylls being seen doing some great adventurous activities it is worth remembering that many young people join Scouting with these images firmly in their minds. With our own centre in North Wales these activities, all at a reasonable cost, are on offer to all our young people so we should be leading the County with our true adventure packages. If your Group has never used the centre please do look at what we can offer and consider booking with us. You do not need any permits to carry out adventurous activities as we do all that and we also ensure that Leaders attending gain valuable experiences to allow their own development. We can help with all aspects of any stay and make your job as a Leader very easy with our One Stop Shop for Adventure.

We have again been the centre of choice for our senior awards push from around the County with all Gold DofE and Queens Scout Award expeditions now being centred around the Countryside offered at the centre. This gives us two times per year when we are busy with the Counties expedition teams. The Scout expedition challenge badge can be completed at the centre as well as the Outdoor and Adventure challenges so consider us for your weekends away for these awards.

The cottage is available for rental and would be worth considering for your family stays in a glorious part of the Country.

We have started to carry out replacement of the now tired flooring with the largest bedroom now having its new wooden floor. Each room takes a couple of days so please be patient as we work through all the rooms.

Fay O'Malley and her husband John continue to do sterling work to ensure the centre is clean and tidy when people arrive and we get very, very good value for the few hours a week we pay for. We are very grateful for all that they do for us each and every week. Catering for fully catered groups can now be provided with us working with a local caterer and our full catering packages have been really commended.

We had a big push on summer camps for 2019 this year and are pleased to say that by the end of January we had five weeks of the summer holidays fully booked. This is great to see and a couple of them are returning customers.

We were this year shortlisted for an award in the Great Outdoors Magazine awards and although we did not win the publicity we received was very welcome. We hope that you all voted for us.

The centre continues to get people re booking year on year. Again in this twelve month period over 40% of bookings were returning customers again showing that our level of commitment to quality is justified. We continue to use the evaluations that we receive to ensure that we constantly develop both our programme of activities and the facilities the centre offers and we now see evaluations from returning customers reflecting their appreciation that we listen to even the smallest items.

Again we held the Gang Show at the Royal & Derngate theatre as part of our 3 year deal. Due to having a 1 year get out clause our dates were not secured and we unfortunately had to move to the end of May. This did cause problems with securing cast and volunteers as it clashed with testing in primary schools, half-term holiday and a Take That concert. Our audience numbers were also down this year. Despite this we were still able to secure a strong cast and a team of volunteers.

We again offered groups a discount on booking their groups in however this was not supported as well as previous years. Our Civic reception on the Thursday night was also in low attendance by District. Reasons for this could be that there was a county night and the Take That concert.

Feedback from our audience were great after each performance. Comments were made regarding the quality of performance and content, having a live band, the inclusion of previous cast members for our 60th number and the overall show itself.

As this was our 60th show we made it a little special for all involved by producing our own commemorative badge which every single person involved in this year's show received. We also produced a commemorative polo shirt especially for the anniversary. We also included a number dedicated to the anniversary that saw past cast members take to the stage again and sing some classic Ralph Reader songs. We were delighted with the support that we received from this.

The show once again included a cast that comprised of Beavers, Cubs, Scouts, Explorers and Network. While backstage we had an army of volunteers that created costumes, made scenery, controlled the mics and spotlights, and made the tea; without this army the show couldn't have happened. Our committee continues to fundraise throughout the year ensuring that we have funds in the bank to support what the show needs.

Our accounts for 2019 were produced in April, before this years show, therefore they do not include this show's takings. The show again made a profit. Due to the continued commitment from our committee we were also able to buy much needed equipment.

Unfortunately our previous Chairperson resigned unexpectedly meaning that we, the committee had to wait for direction from district before proceeding as we normally would have. District did try to recruit a SASU manager however one has still to be appointed meaning an acting SASU manager was put in place. Due to the lack of knowledge around Gang Show that this person had things did not go as smoothly as they could have. Despite a lack of Gang Show knowledge we were grateful for his input. I was not appointed as Chairperson until February so we had a lot to do in a little amount of time. Despite all of this the people that sit on our committee were extremely dedicated to Gang Show and with lots of time and determination we were able to ensure that the show went on, it was a great show and it made a profit.

I would like to give my sincere thanks to all those that are involved in Gang Show for all of their hard work and time that they put into allowing our young people to have this amazing opportunity that really does change their lives.

Northampton Scout Shop

Not such a rosy year at the district shop!

2018-2019 was a troublesome year for the shop. 'Alternative avenues' for buying your Scouting items, i.e. direct sales from Scout Shops Ltd, has seen our sales fall, and this coupled with staffing problems and stock supply issues has seen the shop have its first trading loss in years.

Our thanks go to Lou Ousley who has managed the shop for some time, has now stepped down to help juggle family life. Hope she will back as a staff member soon.

Since I have taken on the role, we have concentrated on building the staffing team, which I can now say is now (fingers crossed) at 110%!.

Stock is now at a level that I believe is sustainable, with all basic needs in stock, uniforms, badges and more. We have tried diversifying with 'extra' things, such as expedition ready meals, pioneering construction kits to increase income, but only stocking when there is a good facebook response. We are now stock ordering every week, so no one is waiting more than they need to when we run out of anything.

Postal badge ordering will be up and running by September this year... look out for the communications.

Our overheads are getting a serious look at also. Profit is not always related to the things you sell, but relates considerably to our overhead costs when sales are lower.

97 Ivy Road is not just the location of our district scout shop, but has the remnants of the district archive, and is the home of the district museum ... somewhat unkempt and in need of a sort, but there all the same. If you have spare time and what to help with this project then let me know.

This year has been another busy year for the team, however it has also been a difficult where we have seen our membership lower due to members going off to Uni and others feeling the way the team has been made to operate is not the same. We have lost some contracts within the town, but gain a few back from Wellingborough and Rushden. We are now seeing the poor harvest of decisions made outside of the team a few years ago. We need to look at the work we carry out due to changes in the purple guide tightening of regulations, organisers of events require their first aid cover to be able to do more than we are allowed to do, plus there is more choice of teams around. The team needs to address this quickly if the team is to continue to operate.

As reported last year we have moved to a new storage area in one of Wreford yards with security however between the Friday before Christmas and Boxing Day we had one of our ambulances broken into and all the equipment stolen. Fortunately we were able to claim on the insurance and the kit is slowly being replaced.

We lost our HQ at Westbridge last year and have been given the old Shipman Scout hut at the Shipman Centre as a replacement. The building had a major electrical fault when we took it on which we have been trying to get fixed. Unfortunately, despite the best efforts of our electrician, we have been unable to get the Council who own Shipman to do the work their side that is required to get the fault fixed. Once we have light we will be able to sort the room into storage and will give us back a training room which we can use to further the training of our team.

We have been grateful of the support from Rutland Medical Team who are happy to with the team, this gives us an Advanced Paramedic and a practicing Emergency Nurse Practitioner to give us help and advice. They have joined us on several duties and we have also been invited to cover bookings for them at Rutland Water when there team were unable to attend. A good working relationship has been formed.

We have completed some interesting duties over the year which have included Halloween at East Carlton Park, Vikings and Jousting at Rockingham Castle, Tour De Triggs endurance hike around Oxford/Banbury area, Wild and Wooley scramble on Boxing Day, St Patrick's celebrations, Don White Rugby Festival, Barclaycard Goes Dancing, Spires and Squires cycle run and the list goes on It was a pleasure to be part of the Big Sleepout held at Overstone Activity Centre, ensuring everyone was kept safe and well.

Everyone who works with us sees the unique scouting qualities that we bring to medicine and is very keen to help us achieve more. We hope that things will improve over the coming months.

The Trustees (District Executive) present their formal annual report and financial statements for Northampton District Scout Council for the year ending 31 March 2019.

Governing Document

The Northampton District Scout Council is a charitable trust formed by a Royal Charter which gives authority to the Bye Laws and the Policy Organisation and Rules of the Scout Association. Trustees are appointed and trained in accordance with the Policy Organisation and Rules of the Scout Association and Trustees who acted during the year are listed in this document.

Objectives of the Charity

The District actively engaged with, and supported, young people living in the Northampton Scout District in their personal development empowering them to make a positive contribution to society.

This is achieved by young people, in partnership with adults, working together based on the values of Scouting and enjoying what they are doing and having fun, taking part in indoor and outdoor activities, learning by doing, sharing in spiritual reflection, making choices, undertaking new and challenging activities and making and living their Scout Promise.

Public Benefit Statement

Scouting complies with two key principles set by the Charity Commission with regard to public benefit in that it helps young people in their personal development, empowering them to make a positive contribution to society; and Scouting in Northampton District is open to young people aged 6-25 and adults.

Full membership is restricted to young people and adults who are willing to make the Scout Promise. The District has processes in place to support those who need help to pay subscriptions, buy uniform or take part in activities so that young people are not excluded from activities if they are unable to pay. The benefits of Scouting are further demonstrated throughout this report.

The Trustees believe that they have met the Charity Commission's public benefit criteria for both the advancement of education and the advancement of citizenship or community development.

Review of Developments, Activities and Achievements during the year

The charity continued to provide support through Scout Groups and District Units to provide a wide range of activities and facilities during the year. Once again, the Trustees would wish to thank all the volunteer leaders who give so selflessly of their time and energies at Group, Unit and District level.

We would, as Trustees of the District, wish to thank our Treasurer – Caroline Lomas, who has ensured that our financial position is regularly supported and monitored.

During the year the Trustees have been pleased to support the redevelopment of buildings at the Overstone Activity Centre to provide a new District resource and to support the purchase of new activity equipment including the replacement ambulance for NEAT, the "cavebus" and several other new activities at Overstone. The Trustees also recognise that the District Minibus and Bell Boats may be reaching the end of their economic lives and that long-term plans for these will be needed in the coming years.

A year ago, the Trustees noted that the review of our insurances had saved a significant sum of money. Unfortunately, several claims on the insurance over the last year has increased the premiums again.

Finally, the Trustees would wish to thank Craig Kidd and his team for the leadership they are giving to the District.

Financial Review

The Trustees have continued to manage the District funds prudently, as is demonstrated in the financial section. There has been a "managed" reduction in the balances of around £5000 as the Executive have approved spending to improve the District facilities and assets. The Executive recognise that this is not a trend that can continue on a regular basis and have taken steps to start some targeted fund-raising activities.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2019

1 Accounting policies

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

The financial statements have been prepared to give a "true and fair" view and have departed from the Charities (Accounts and reports) Regulations 2008 only to the extent required to provide a "true and fair view". This departure has involved following the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland" (effective 1 January 2015) rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2015 which has since been withdrawn.

Accounting convention

The financial statements are prepared on a going concern basis under the historical cost convention.

Incoming resources

Incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy. Any incoming resources received in respect of bookings at the Activity Centres which occur after the year end are deferred until the following year. Legacies are recognised in the financial statements upon receipt.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources. Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Charitable activities

All activities are planned in accordance with the charity's aim of promoting the development of young people.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write of each asset over its estimated useful life.


